An exchange program between Mississippi College School of Law and European Faculty of Law is a **unique opportunity** for Evro-PF students to live and study abroad on one of the best law colleges in Mississippi, USA. This international education program is the **first of its kind in Slovenia** and allows Evro-PF students who are in their final

year of completing their Bachelors of Law degree or completing a Master of Laws or Doctorate of Judicial Science to attend MC Law as **exchange students**. The exchange period for Evro-PF students begins in the beginning of July and extends throughout the Fall Semester.

Exchange Agreement brings double advantage to the students of Evro-PF:

- Exchange students pay **no tuition fees** to MC Law during the period of exchange and Evro-PF recognizes classes satisfactorily completed at its American partner faculty;
- Students who participate in the exchange have the opportunity to stay at the MC Law for an additional payable semester to complete and **earn an American Master of Laws degree (LLM)**. This degree allows students to **accede to the USA bar examination in American jurisdictions**, such as New York, Washington

D.C. and California and to improve their employment opportunities in the United States. If simultaneously fulfilling academic requirements at the Evro-PF students will be able to attain a Joint American-Slovenian degree.

MC Law provides participants with **“one on one” academic counseling and assists** them in choosing the best schedule to achieve their academic goals. Exchange students are allowed to take regular classes alongside American fellow students. Further, MC Law enables participants to join many student clubs and organizations, such as the Oil & Gas Law Society, the Law Student Bar Association and many more.



Selection of candidates for studies in the USA is very competitive and applicants must possess advanced **English language skills**. Evro-PF leads the selection of candidates who in order to be eligible for the exchange program have to attend a **special Preparatory Program** of legal education organized by the Evro-PF. Preparatory program includes three academic courses on advanced English Legal Terminology, Introduction to US and Comparative Law, and Legal Writing and Methodology.
